# Orthodontics

- 1. MCN meeting had been held but was not very well attended. LDC representation important in these meetings.
- 2. CDO pleased with orthodontic contracts, 500 more patients had been seen this year than last and for the same amount of money. Efficiency had been improved.
- 3. Orthodontic contracts would re tendered in 2016.
- 4. Data although being provided by orthodontic practices was still not being passed on to GDPs re waiting lists.

# **Dental Foundation Training**

- 1. New electronic portfolio being developed for September 2015.
- 2. There had been a fall in trainer numbers it was felt this was down to a number of issues:
  - a. Trainers having to meet targets for core contracts. Some doing more private work.
  - b. Training practices being bought by dental corporates.
  - c. Practices employing associates to be sure of hitting targets.
- 3. Extended training will come from next year's budget.

## 15/35 Local Commissioning - Update

A response has been received from Mr Andrew Davies, Chair of ABMULHB. Unfortunately the response did not address the issues raised in the complaint letter. All the correspondence will be made available to committee members on request.

The Chair met with Steve Combe, Secretary to the Board. It was decided that Mr Combe would seek legal advice regarding the failure to follow proper procedure in the commissioning of dental services by the Swansea Locality. The LDC awaits the reply.

Anwen Hopkins had contacted Dick Burkin, BDA Wales Director and after consideration he suggested three possible options:-

- 1. wait for LHB legal response.
- 2. Proceed Judicial Review, which would prove to be very costly.
- 3. Public Procurement Legislation this would need individual GDPs to carry forward and would prove very costly.

The general feeling of the committee was that the whole process of commissioning the services in question should be revisited. It was noted that the tendering processes for Orthodontics and the Parkway Clinic had been very thorough and it was felt that the commissioning of dental services in Swansea City Centre should have been treated in the same way.

It was decided to refer the complaint to the Public Service Ombudsman for advice.

## 15/36 Occupational Health - Update

## 15/37 In Hours Access - Update

There had been a delay in sending our termination notices to the current GDPs providing services and sending out the requests for expressions of interest in providing the new service whilst the procurement department gave their advice on the process.
