RE: Morgannwg LDC Response to SBUHB Consultation on Proposal for the Relocation of Paediatric Dental General Anaesthesia Services from Parkway Clinic (PWC) to Swansea Bay University Health Board Hospital Site (SBUHB).

Thank you for your email dated the 27th December 2019 and the response from the Local Dental Committee (LDC) in relation to the above consultation.

We formally received and discussed the document at the January Liaison Group meeting. As agreed since there have been a number of key meetings within the Health Board during the early part of 2020 it was necessary to understand their outcome before formalising a response to the LDC from the Health Board.

We also discussed at the Liaison meeting, the reference in your response to the Referral Management Centre (RMC) is outwith the parameters of this consultation and so will not form any part of this reply. However, we understand the queries in relation to this part of the service and would look to address these through the Liaison Group meetings as a specific agenda item.

We need to advise the LDC that Parkway Clinic (PWC) informed the Health Board both in writing and at a subsequent meeting in January 2020 that they no longer wish to contribute to the proposed Hybrid Model. As such, we are now working on the development and implementation of the Health Board Model which with revised timescales. The Health Board's Senior Leadership Team (SLT) confirmed this position at a meeting on the 5th February 2020. The SLT also confirmed that the relocation remains a high priority for the Health Board based on the medical risk.

It would be helpful to respond to the remaining queries in turn, specifically taken from point five in the LDC response - *Overall Views of GDPs*, and this is attached.
