#### **Update from SBUHB**

- PCR testing for staff any staff member requiring PCR testing, advised to contact HB to arrange.
- Contract Variation Document still being worked on, will take time as each contract needs to be looked at individually.
- Paul Whiteside had agreed to give a new FPC17 guidance talk date to be arranged.
- There had been some teething issues reported around the referral of patients by RMC and the resulting empty appointment slots. Several practices had reported unfilled slots and required confirmation from HB that this would not affect their target totals at year end and lead to them playing catch up. The HB had confirmed if they were unable to provide the required number of patients that had been agreed, they would credit the practice. LDC to take this issue to next Liaison Group meeting for clarification in writing for affected practices.
- In Hours Access Providers each in hours access patient will count towards the practice's new patient target, the practice will not have to offer a full course of treatment to these patients. If a practice should offer a course of treatment to these patients, they will then count as two.

## Open Discussion of WG GDS contract April 2022

- It was felt to be a good exercise for practices to analyse their historic patient lists, they may find the numbers to be less than their current targets.
- HB looking at extractions: simple, bone removal and soft tissue were to be included on FP17.
- BDA Associate contract draft, a new updated version is imminent.
- Practice Associates were now able register on eDen.
- The importance of keeping records and monitoring data was reiterated. If there were any problems, practices are encouraged to contact LDC for support

#### **Any Other Business**

- The new CDO Andrew Dickenson was now in post, LDC to invite him to attend the next meeting.
- The Orthodontic tender had been published today at 17.00, there were to be 34,000 UOAs and four contracts in SBUHB.
- HEIW had approved a Specialist Oral Surgery post from September 2022 to be based in Cardiff and Merthyr.
